Mines in Palnadu & Krishna districts were considered in Zone - II (21 mines), and Zone - III comprises 31 mines from Annamaiah, Nandyal, & YSR Kadapa districts.

Group Classification: Based on annual mine production, three groups have been classified:

> A Group: Mines with annual production of more than 3.00 MTPA

➤ **B Group**: Mines with annual production of 0.75 MTPA to 3.00 MTPA

> C Group: Mines with annual production below 0.75 MTPA
